2021 Annual Report

In 2021, our partner schools and organizations continued to contend with the impact of Covid-19 on children and families, schools, and communities across the US and the world. FAST worked with our partners to adapt to meet the needs of families, as well as schools, as we all navigated the ever-changing landscape. Some programs were conducted virtually, others in-person, and some utilized a hybrid approach.



Regardless of these challenges, our FAST teams remained committed and were able to provide high-quality programming to children and families. Many lessons were learned, and new approaches developed; our sites continue to stay dedicated and look forward to returning fully to in-person programs as soon as they are able.

2021 Highlights...

- **5 pilot programs** across WI of Early Childhood FAST expanded to new sites, serving young children and their families.

- **The Czech Republic** became the latest country to host FAST Programs, running at both the Elementary and High School levels.

- A new partnership was initiated with the Wisconsin Education Association Council (WEAC) to provide training to educators across the state through our FAST Institute of Family Engagement.

- **FAST programs expanded** into new states at sites in Georgia, Pennsylvania, Arizona, and South Carolina.
